Welcome to the 2018 Annual Report.

If you read the newspaper, follow Grow Ashland on social media, or simply drive through the county, you will notice that the atmosphere in our community is very positive and strong. There is growth and development taking place everywhere; in the Ashland Business Park, along the US Route 250 Corridor, and in the Villages of Hayesville, Jeromesville, Loudonville, and Perrysville.



Below are the highlights from our stellar year of growth as we celebrated five ground-breakings, several entrepreneurs opening new businesses, and the opportunity for job creation.

In February, we received word from SJE, Inc. that they had decided to build their new state-of-the-art facility in our Ashland Business Park instead of renovating the building on Ohio Street. "Project Ruby" was a four-year conversation that included SJE representatives, elected officials and resources to help them through the process of constructing a \$10,350,000 facility in order to retain their 59 employees.

In the Spring, we assisted the City of Ashland Engineer, Shane Kremser in successfully obtaining three grants toward the construction of the Wells Road Extension north of the new SJE, Inc facility in the Ashland Business Park. Oftentimes, projects that involve manufacturing companies can result in funding sources that allow for road and infrastructure improvements. Our collaborative efforts allowed us to partner with Team NEO/ JobsOhio, ODOT Jobs and Commerce, and the Transportation Improvement District to leverage funds in the amount of \$613,250.

The largest project that Grow Ashland has taken on to-date is 'Project Tide', which was COMTEX (Central Ohio Medical Textiles). Myles Noel first contacted our office in August 2017, inquiring about land in the Ashland Business Park. After several meetings and discussions, it was determined that the former Cooper Farm located on the US Route 250 By-Pass would be the best location for this commercial laundry facility. The hours that it takes to get a new company into our community are endless, especially when you are competing with another county. When a company is considering your community, they are looking at the available utilities, zoning, workforce, incentives, financial support, and collaboration among the local and state governments. Grow Ashland received the news in August 2018, one year to the date of the initial call, that Ashland had been chosen. The capital investment is \$20,740,000 with a commitment of 75 to 100 employees.

Looking forward to 2019, we expect more growth not only in Ashland but throughout the entire county. Those retail businesses that everyone hopes will come to Ashland are actually looking at Ashland right now.



BUSINESS RETENTION AND EXPANSION VISITS

The Grow Ashland team was joined by volunteers and elected officials on more than twenty-five scheduled Business Retention and Expansion visits throughout the county during 2018. The visits are an opportunity for us to keep a pulse on the county's industry trends. There were two recurring themes during the visits. The positive take-away is that area manufacturers and distributors are seeing an increase in market share and sales; leading to expansions and diversification among product lines and increased workforce needs. The flip side is that workforce demands are hard to meet.

In an effort to find options for companies with employee needs, we partnered with our workforce resources in the community: Ashland County-West Holmes Career Center's Bill Mellick and his YOY Leadership Program, Erv Howard with North Central Workforce Alliance, and Dan Phillip with Transformation Network.

While Grow Ashland generates the opportunity for job creation, we rely on our workforce partners to develop options for the companies. We have full confidence in their abilities to create tailored solutions for each company.

2018 EVENTS

April 3 - SJE Groundbreaking - The Minnesota-based electric control panel manufacturer broke ground for their new 50,000 sq ft state-of-the-art facility in the Ashland Business Park. The ESOP had been in its original Ohio Street location since purchasing CSI Controls in 2008. Employees moved into the new location in January 2019.

April 18 - Aber's Towing & Crane Groundbreaking - Family and community members joined Aaron Aber in celebrating his third-generation towing company's relocation and expansion to Commerce Parkway during April's groundbreaking ceremony. The new 20,000 sq ft facility will allow for quicker response time and more space to store and maneuver the trucks and equipment.

May 11 - Primal Fitness (Crossfit and 24-Hour Gym) Groundbreaking - Gym owner Craig Nolletti commemorated his third Ashland expansion in as many years with his wife and children during May's groundbreaking. The new 20,000 sq ft gym, located on Commerce Parkway, opened Fall 2018.

June 14—Summer Press Conference at Mitchell's Orchard - Our summer press conference represented four local entrepreneurs that chose downtown for their new business start-ups and expansion. Corinne's Salon, Fig & Oak, The Taproom on Main and Vinyl Marketing shared their upcoming plans for investing in downtown. Michalina Lacy with Small Business Development Center (SBDC), located in Ashland University, spoke on the services and counseling available at no-charge through her office.

June 28 - Pioneer National Latex Groundbreaking The 79-year Ashland balloon manufacturer broke ground in June for an additional 12,000 sq ft warehouse to support the 2.5 million balloons manufactured each day at its facility. The project was complete by Fall 2018.

July 16—Economic Update Luncheon at Whispering Pines Event Center - Kathy provided a mid-year update on current economic activity, projects and initiatives to Grow Ashland members. Linda Barita, MAGNET Director of Strategic Alliances, shared recent statistics on its Ohio manufacturers survey and reviewed results that included workforce best practices.

October 4—COMTEX Groundbreaking and Ground Blessing - In August, COMTEX announced that they had chosen Ashland for its first regional expansion of its Columbus-based, commercial healthcare laundry facility. October's groundbreaking and ground blessing celebrated their future 70,000 square foot state-of-the art building, located on the 250 bypass. Completion is slated for Fall 2019.

October 18—Ashland Business Park Food Truck Rodeo - Grow Ashland worked with business leaders in Ashland Business Park and surrounding area to coordinate a food truck rodeo for October's Manufacturers Month. Vendors included Charcoal Mafia, Dan's Deli, Grant's Guac and Roll, Mitchell's Orchard and Moto Pizza. The event was an opportunity for employees to have convenient lunch options while enjoying fresh air and mingle with other area employees.

MANUFACTURING ROUNDTABLES

Based on the positive response we had with our 2017 business roundtables, we facilitated four in 2018. Lippert Enterprises, Ohio Electric Control, Barbasol and Ashland Scale each hosted one, allowing area executives to congregate and discuss current trends.

TRANSPORTATION IMPROVEMENT DISTRICT INITIATIVE

The Transportation Improvement District (TID) was established in March of 2018 through the Ashland County Commissioners. The TID was formed to serve a single function for the purpose of coordinating and financing transportation infrastructure improvement programs such as roads and bridges. In most cases, the TID funds are associated with Jobs and Commerce. In May 2018, the TID applied and received their first grant for the Wells Road Extension in the Ashland Business Park.

2018 PUBLICATIONS

2018 RECOGNITION

ASHLAND County, Ohio is Ranked #5 in the 2018 Governor's Cup of Top Micropolitans



We are proud to announce that Ashland, Ohio has been ranked #5 Micropolitan for 2018. While Ashland has continued to grow with the Micropolitan rankings, this is the first year we've broken the Top 5.

Site Selection Magazine's Governor's Cup is the most prestigious national award for economic development; with Micropolitan being a community less than 50,000. The award is based on the previous calendar year's projects; including start-ups, expansions and relocations. To qualify, each project must create 20+ jobs, be \$1M+ new construction (including land and building), or 20,000 square foot construction.

#10 Economic Growth Potential for Mid-Sized Metros Business Facilities Magazine 2018 Rankings



In early 2018, Kathy and Erin shared Ashland's increasing economic momentum with Business Facilities Magazine and asked to have the county thrown in the hat for consideration with the magazine's 2018 rankings. In July, we were notified that Ashland had ranked #10 nationally in what they consider their most important category, "Economic Growth Potential for Mid-Sized Metros". The Top 10 list included Reno, NV, Grand Rapids, MI and Lexington, KY.

Factors in the ranking consideration include recent projects, incentives, diversity of growth sectors, support for startups, workforce development, demographics, development strategy, and cost of doing business.

The Grow Ashland team spent 2017 and 2018 working with Advantage Marketing to fine-tune the Grow Ashland message. Kathy and Erin are involved in various organizations that strengthen not only community relationships, but helps build opportunities for economic development within Ashland County. These opportunities include, but are not limited to, financing, incentives, infrastructure, and job creation.

The knowledge gained strengthens Grow Ashland's economic development toolbox.

Kathy's Various Roles

Community Improvement Corporation of Ashland (CIC), Ohio Board Secretary - The CIC handles economic development projects and can sell land owned by a municipality.

Community Reinvestment Area Housing Officer - The CRA is a tax incentive that helps with not only commercial projects but residential housing as well.

Enterprise Zone Manager - The Enterprise Zone is a tax incentive for manufacturing, distribution and research projects.

Vice President of Erie Basin RC&D Council, Inc - Erie Basin offers financing through their revolving loan fund and downtown revitalization loan program.

Mohican Area Growth Foundation (MAGF) Executive Director and Board Secretary - MAGF was created in the 1980s as the economic development arm for Southern Ashland County.

Transportation Improvement District Secretary / Treasurer Transportation Improvement District - This allows the opportunity to bring attention to projects that require road or transportation infrastructure improvement.

Ashland County Council on Aging Board Member - The information gained from sitting on the board helps with economic development projects involving assisted living, condominiums and retirement homes.

Erin serves as the Ashland Land Bank Assistant Director. Her role includes supporting the board with project management, grant submission and administration. Having a hand in addressing blight around Ashland County helps promote a more attractive landscape for developers and investors considering Ashland.

2019 FORECAST

The conversations and projects that are lining up for 2019 continue to represent various markets and a combination of expansions and new business coming to Ashland.

The diversity is a healthy sign of balanced growth throughout the county.

INITIATIVES

Foreign Trade Zone (FTZ) – This is a collaborative effort between the Ashland County Commissioners and Grow Ashland. With the assistance of an outside consultant, we are in the process of setting up the Heartland Ohio as a multi-county FTZ. The grantee will be the Grow Ashland Economic Development Office. The goal is to have the entire Ashland Business Park established in the Foreign Trade Zone. This will allow for not only the companies in the park, but the ones throughout Ashland County, as well as surrounding counties, to obtain the benefits of the lower costs by reducing, eliminating, or deferring duties.

ANNOUNCED PROJECTS

CoffySpace is remodeling a downtown building to accommodate an open concept space which will serve as an office for Flight Media and allow entrepreneurs a place to gather and start their businesses.

Eco-Flo is relocating to Commerce Parkway to expand their distribution and warehouse components along with adding pump assembly and production.

McClain Development is set to purchase the Hospice of North Central Ohio building in the spring. It will be renovated for assisted living.

Primary Colors is relocating to Commerce Parkway to allow for expansion which will include a cotton candy production line.

Union Lofts is breaking ground on Sugarbush Drive this spring for a 47-unit apartment complex that will provide quality, affordable housing.

Vinyl Marketing is in the midst of remodeling downtown's Stickman Building to accommodate their growing staff.
